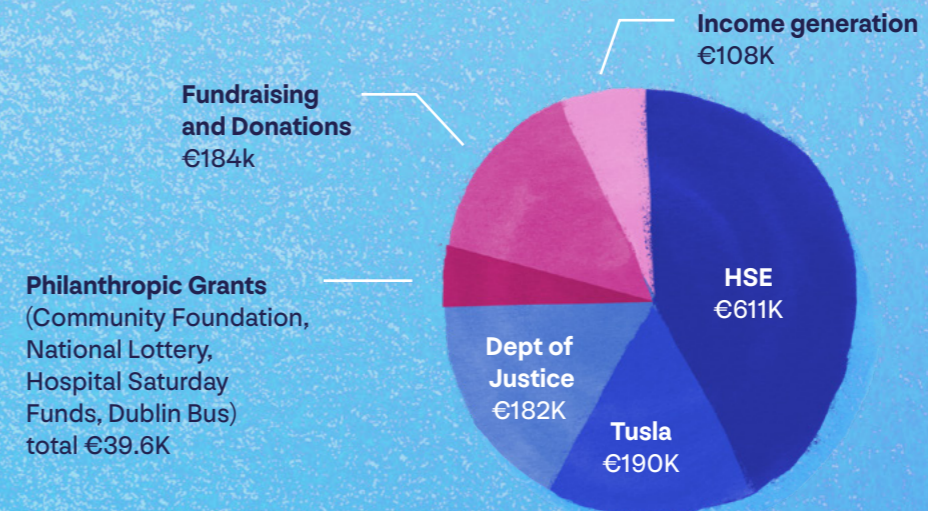

We are fully compliant with the Charities Regulator Governance Code and have achieved Triple Lock standards in fundraising.

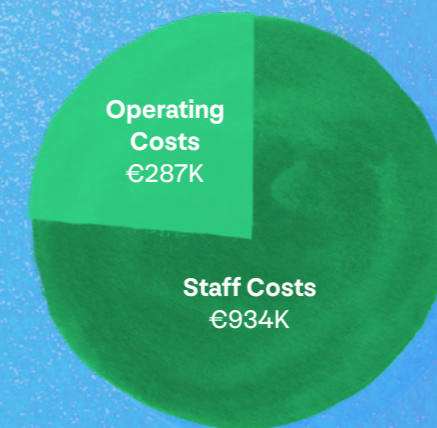
